In the table the 1.4 point requires 8 years after-sales services.

Are these two things different? Did we misunderstand something?

1. Answer:

There is the following required specification:

- Hydraulically operated dredge pump with an aluminum screw feeder, together with quick coupling elements (4-4 pcs), hydraulic telescopic extension, ring-clamp (8 pcs), 200 m long pipeline

After this:

- 1pc hydraulically operated feeding screw, 6 m spiral tubing incl. couplings, 25 m flat tubing Ø 102 mm with camlock quick coupling with buoyancy tube. 10 pc floaters, 5 m flat tubing with quick coupling and end nozzle, 1 pc suction nozzle, 1 pc attachment 0.9 m, 1 pc extension 0.7 m, 1 pc bracket set for dredging hose.

We would like to inform you and also the Water Directorate about that the first requirement (Hydraulically operated dredge pump with an aluminum screw feeder, together with quick coupling elements (4-4 pcs), hydraulic telescopic extension, ring-clamp (8 pcs), 200 m long pipeline) is includes the second (1pc hydraulically operated feeding screw, 6 m spiral tubing incl. couplings, 25 m flat tubing Ø 102 mm with camlock quick coupling with buoyancy tube. 10 pc floaters, 5 m flat tubing with quick coupling and end nozzle, 1 pc suction nozzle, 1 pc attachment 0.9 m, 1 pc extension 0.7 m, 1 pc bracket set for dredging hose).

It means that if we give offer for the hydraulically operated dredge pump with an aluminum screw feeder, together with quick coupling elements (4-4 pcs), hydraulic telescopic extension, ring-clamp (8 pcs), 200 m long pipeline we could not give offer for the 1pc hydraulically operated feeding screw, 6 m spiral tubing incl. couplings, 25 m flat tubing Ø 102 mm with camlock quick coupling with buoyancy tube. 10 pc floaters, 5 m flat tubing with quick coupling and end nozzle, 1 pc suction nozzle, 1 pc attachment 0.9 m, 1 pc extension 0.7 m, 1 pc bracket set for dredging hose.

Based on this fact if it is possible please delete the following required specification or combine the two line of the table: *1pc hydraulically operated feeding screw, 6 m spiral tubing incl. couplings, 25 m flat tubing Ø 102 mm with camlock quick coupling with buoyancy tube. 10 pc floaters, 5 m flat tubing with quick coupling and end nozzle, 1 pc suction nozzle, 1 pc attachment 0.9 m, 1 pc extension 0.7 m, 1 pc bracket set for dredging hose.*

2. Answer:

The Contracting Authority accepts the remark, and the following requirements:

- *1pc hydraulically operated feeding screw, 6 m spiral tubing incl. couplings, 25 m flat tubing Ø 102 mm with camlock quick coupling with buoyancy tube. 10 pc floaters, 5 m flat tubing*
- *with quick coupling and end nozzle, 1 pc suction nozzle, 1 pc attachment 0.9 m, 1 pc extension 0.7 m, 1 pc bracket set for dredging hose”*
